<b>PLAN B FIXED BROKERAGE PLAN</b>	Rs.9/- per executed order for Equity Cash (Delivery + Intraday), F&O, Currency & Commodity Trading.
<b>PLAN C MONTHLY BROKERAGE PLAN</b>	Fixed brokerage every month- Rs. 999/- For Equity Cash, F&O & Rs. 999/- for Commodity Trading and Rs. 499/- (For Currency Trading) you'll be charged 2.5% of the trade size brokerage for every trade executed. However, as soon as the total amount of your brokerage reaches Rs. 999/- monthly or Rs. 499/- monthly the brokerage for the trades placed in the rest of the month will be zero.
